Entry Limitations and Regulations – please read carefully

According to Chapter 1, Section 27 of the AKC Obedience Regulations, combined entries for all classes are limited to 8 hours per judge each day. Entries will be accepted in the order received, subject to the following: All regular class entries have first priority, and will be accepted up to the limits for the assigned judge. Optional titling classes have second priority, and will be conditionally accepted as received. After closing, and processing of regular class entries, these entries will be accepted up to the limits for the assigned judge. Non-regular class entries have third priority, and will be conditionally accepted as received. After closing and processing of regular and optional titling class entries, entries will be accepted up to the time limits for the assigned judge.

All classes will be run in **ascending jump height order** beginning with the lowest jump height entered in each class (except to accommodate handlers with multiple entries).

Fee Schedule – all AKC fees are included

Obedience Regular Classes and Optional Titling Classes

\$25.00 for the first entry of a dog in regular and optional titling classes each day

\$20.00 for each additional entry of the same dog in these classes each day

Rally Classes

\$25.00 for the first entry of a dog in rally each day

\$20.00 for each additional entry of the same dog in rally each day

Non-Regular Obedience Classes

\$20.00 per entry in Veterans and Wild Card Classes (Saturday and Sunday)

\$10.00 per entry in Pre-Novice (Saturday and Sunday)

\$10.00 per dog for entries in Brace, 2 dogs of the same breed (Saturday only)

\$ 5.00 per dog for entries in Team, 4 dogs per team (Saturday only)

Note: Team may enter an 5th dog as an alternate with no entry fee. Your team determines the 4 who will actually compete at the time the class begins.

Refunds will be given per AKC regulations and for entries withdrawn in writing before the closing date and time. As a courtesy to exhibitors, DOCG will give refunds for bitches that come into season after the closing date of the trial; please submit a letter of explanation from your veterinarian along with your request for such a courtesy refund.

No refunds for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

Changes or corrections to entry forms must be received in writing prior to the close of entries.

Indicate **'UDX'** if you are entering both Open B & Utility B and you want no entry if one class or the other is already closed due to entry limitations (Obedience Regulations: Chapter 1 Section 27).

Obedience High Jump Height is required for all entries in classes with jumps in the match and trials. **Rally Jump Height** is required for Advanced and Excellent classes.

Entry Fees must be paid in advance (via Paypal) for online entries. Please make one payment for the combined total of all entries and pre-orders. Returned checks do not constitute a valid entry fee; the club will add a collection fee to any returned check.

Move-ups will be accepted per AKC regulations if the class is not full. Completed and signed move-up form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging.

Show Site will be open to exhibitors for setup from 6:00-8:30 pm Friday evening, and at 7:00 am Saturday & Sunday morning. No overnight parking; no dogs may be left in the building overnight.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

- I-26 North to exit 54; follow SC 72 West to Clinton

DOCG is pleased to offer an OC Match with ring time for “run-throughs” in the Novice, Open, and Utility rings. Each handler may select class exercises to be performed within a block of time. 5 minutes for Novice and Open rings (plus group sits & downs); optional 5 or 10 minutes for Utility ring.

There are no prizes, ribbons, scoring or placements for the Match.

Verbal corrections and gentle guidance will be permitted.

No food or toys will be permitted in the rings.

Group sits and downs are included at no additional charge for dogs signed up for Match Novice or Open ring time. Group exercises will be conducted at appropriate intervals at the club’s discretion.

Match Ring Time entries will be accepted only in advance, and only for dogs that are entered in our trials on Saturday or Sunday (any class). Match entries will be accepted in the order received up to match ring time limits.

Match Ring Time limit is 5 minutes per dog (Novice & Open) and optional 5 or 10 minutes per dog (Utility).

High Jump Height is required for all classes. Dogs will be assigned ring time by armband number. Match will be run in **ascending jump height order** beginning with the lowest entered in each class (except to accommodate handlers with multiple entries).

To enter, specify Ring (Novice, Open, Utility 5 or Utility 10) on your entry form, and submit payment with your trial entry. You may enter online.
